Dear Residents/Stakeholders/Consultees

Thurlby Parish Council, as the qualifying body, has prepared a Neighbourhood Development Plan (NDP) for the period to 2036 for Thurlby Parish, with the help of the local community. The NDP sets out a vision for the future of the parish, and planning policies which will be used to determine planning proposals locally.

Thurlby Parish Council is now inviting comments on the proposals in this Pre-Submission version of the NDP before it is submitted to South Kesteven District Council for formal consideration and wider consultation.

The consultation opens for comment at 00.01 am on Monday 30th October 2017. The deadline for comments to be received by Thurlby Parish Council is midnight on Sunday December 17th 2017.
